STAR SPANGLED SPECTACULAR COMMERCIAL VENDOR REGULATIONS

- Booth spaces are \$150.00
- Electricity **WILL NOT** be provided by Doublehead Resort. Vendors who require electricity must provide their own generator, please contact Doublehead Resort for restrictions on generator placement.
- Your space is a basic 10x10, however should you require additional space we may be able to accommodate you. Please note on the commercial vendor form the amount of space you need.
- If you have a trailer, please give the dimensions including the hitch/tongue.
- Doublehead Resort maintains exclusive rights for bottle water and soft drinks. Commercial Vendors may not sell food or beverage items.
- Parking for commercial vendors will be a short distance outside the event area.
- Your booth (tent or trailer) should be equipped with lights for evening, as most performances will be after dark.
- All set up for commercial vendors must be completed by 12 Noon on Friday, July 4th. You may break down your booth no earlier than 12 Midnight. Your booth must be manned at all times. No vehicles will be permitted inside the event area until all patrons have left on the day of the event.
- Please send a photograph of your booth display or photos of your merchandise as it will appear at the festival. Also include anything of interest about yourself or your business that we may use in pre-event publicity.
- The total cost of your item should include 7% sales tax which includes state and county. It is up to the individual vendor to pay the appropriate taxes. Doublehead Resort will provide the necessary contacts for you to pay the taxes.
- You will be given a wristband for the day for entrance and exit to the event area. You are allowed three people to work your booth. Additional wristbands can be purchase for \$10 per person, in advance if needed.
