We are encouraging participation from vendors by offering FREE booth rental if we don't sell at least 3000 tickets! Reserve your booth today to enjoy this fun freedom filled day!

• Booth rental will be contingent on the actual amount of event ticket sales and are as follows:

•Less than 3000 tickets	FREE BOOTH RENTAL
•3000-4000 tickets	\$300.00
•4000-5000 tickets	\$400.00
•5000 tickets & up	\$500.00

- Electricity **WILL NOT** be provided by Doublehead Resort. Vendors who require electricity must provide their own generator, please contact Doublehead Resort for restrictions on generator placement.
- Your space is a basic 10x10, however should you require additional space we may be able to accommodate you. Please note on the food vendor form the amount of space you need.
- If you have a trailer, please give the dimensions including the hitch/tongue.
- Doublehead Resort maintains exclusive rights for bottled water and soft drinks. Food vendors may sell homemade tea, sweet or unsweet, and hot coffee
- All set up for food vendors must be completed by 12 Noon on Sunday, July 4th. You may break down your booth no earlier than 10p.m. No vehicles will be permitted inside the event area until all patrons have left on the day of the event.
- Parking for food vendors will be a short distance outside the event area.
- Your booth (tent or trailer) should be equipped with lights for evening, as some of the performances will be after dark.
- Please send a photograph of your booth display as it will appear at the event. Also include anything of interest about yourself or your business that we may use in pre-event publicity.
- All prices need to be in increments of \$1.
- Size of portion means: Size of bun, weight of each serving, size of cup, size of bowl. We want to make sure that our patrons receive a fair price for food items, but we also want to make sure that you make money.
- Each vendor should have a sign posted of your pre-approved menu.
- The total cost of your item should include 7% sales tax which includes state and county. It is up to the individual vendor to pay those appropriate taxes. Doublehead Resort will provide the necessary contacts for you to pay the taxes.
- The Lawrence County Health Department may require that each vendor apply for a temporary license. It is the responsibility of the individual vendor to obtain the license. The license will be \$30.00 and applications must be sent into the Lawrence County Health Department no later than June 16, 2010.
